## Fire Department

*Bruce Weymouth has been a great asset, in stepping up as Fire Chief and currently has a team of volunteers. The department is lacking an EMT or EMR, to operate our fully operational and equipped ambulance. The town has a contract with Capital Ambulance for assistance and transport. As well as, the members have been trained in CPR and First Aid and are responding to medical calls, as needed. However, the Town of Osborn is hosting a 7 week EMR Course from March 22 – May 6, 2018. The Classes will be held Thursdays 5pm-8:30 pm and Sundays 8:00 am – 4:00 pm. There will be no charge to any individual taking the course, who will offer their time in supporting Emergency Medical Services for the Osborn Volunteer Fire Department.
